

COUNT 1

The Grand Jury of said county charge that, before the finding of this indictment, prior to the finding of this indictment, CAMILA MARIA MOCTEZUMA, whose name is otherwise unknown to the Grand Jury, under circumstances manifesting extreme indifference to human life, he or she recklessly engaged in conduct which created a grave risk of death to a person other than himself or herself, and thereby caused the death of another person, to-wit: K.H.M., in violation of 13A-6-2(a)(2), Code of Alabama.

COUNT 2

The Grand Jury of said county further charge that, before the finding of this indictment, prior to the finding of this indictment, CAMILA MARIA MOCTEZUMA, whose name is otherwise unknown to the Grand Jury, being a responsible person, knowingly, recklessly, or intentionally caused or permitted a child, K.H.M. (DOB: 09/19/2025), to be exposed to, to ingest or inhale, or to have contact with a controlled substance, chemical substance, or drug paraphernalia, to wit: DID CAUSE OR PERMIT HER CHILD, K.H.M., TO BE EXPOSED TO METHAMPHETAMINE AND AMPHETAMINE, resulting in the death of the child, in violation of 26-15-3.2(a)(3), Code of Alabama.
